





- Logging is one of the revenue-generating operations
- Regular control burns
- Trail will be approved "by permit"

- Lack of safe, comfortable and accessible pedestrian bicycle facilities







NO BUILD ALTERNATIVE

River to Hills Trail gap not completed

Benefits


• Baseline for comparing to Build Alternatives

Drawbacks

- Safety issue with mixing cyclists with traffic
- Doesn't meet objective of completing trails
 network







PROJECT ALTERNATIVE SEGMENTS

Segment A

- Along SR 19 (E. Altoona Road to CR 445)
 - 8-foot Trail, west side of SR 19
 - o E. Altoona Road to Lake Dorr Recreation Area
 - 8-foot Trail, east side of SR 19
 - \circ $\,$ Lake Dorr Recreation Area to 0.2 mi. south of CR 445 $\,$
 - 14-foot trail, east side of SR 19 (0.2 mi. south of CR 445 to CR 445)

Benefits

- Less private parcel impacts at beginning project limits
- Provides recreation connectivity at Lake Dorr Recreation Area (▲)
- Provides direct connection to CR 445

Drawbacks


- Desired 14-foot wide trail results in more parcel impacts and right of way acquisition
- Existing utility poles from E Altoona Rd. to Dorr Rd.

PROJECT ALTERNATIVE SEGMENTS

- Segment B

- Along SR 19 (CR 445 to CR 445A)
 - 14-foot Trail
 - \circ East side of SR 19

Benefits

- No right of way impacts with proposed typical sections
- Provides direct connection to CR 445A without crossing SR 19
- Provides access to Ocala National Forest recreation areas

Drawbacks



- Direct connection to Beakman Lake Recreational Area


Drawbacks

Along CR 445 (SR 19 to Alexander Springs bridge)

- 12-foot Trail SR 19 to Wandering Wiregrass Trailhead (

 - \circ South side of CR 445
- 14-foot Trail Wandering Wiregrass Trailhead to Alexander Springs bridge
 - South side of CR 445

Benefits

- No right of way impacts with proposed typical sections
- Potential connections to:
 - Wandering Wiregrass Trailhead and parking lot
 - o Northern Trailhead Paisley Woods Bicycle Trail
 - Alexander Springs entrance to the Alexander Springs Recreation Area and Yellow Loop Trail

Drawbacks


Additional costs for separate bridge crossing at Alexander Springs (avoids trail users from using vehicular bridge)

- 8-foot Trail CR 445A intersection to SR 40
 - o South side of CR 445A

Benefits

- No right of way impacts with proposed typical sections
- Connects to Astor Park


Drawbacks

• None









PROJECT ALTERNATIVE SEGMENTS

- Segment F

Along CR 445A (SR 19 to SR 40)

- 14-foot Trail
 - \circ South side of CR 445A (except at intersection with CR 445)
- 8-foot Trail
 - South side of CR 445A (500-foot section just north of CR 445 intersection)

Benefits

- No right of way impacts with proposed typical sections
- Connects to Astor Park
- Potential Ocala National Forest recreation connections
- Connects to Alexander Springs via Segments D and E

Drawbacks

• None


